### Footnotes

KNIGHT IN ARMOUR stalked the pace from the four path, started his drive into the final turn, lost some ground passing the quarter pole but dug in from there to slowly gain command and draw clear approaching the wire. DIVINE MASTER quickly took over to rate the pace inside, contested with a slight disadvantage toward the rail on the final turn, dug in to regain the lead and moved clear in midstretch only to be outfinished in later yards. SLAM DUNK rated with the pace two deep on the backstretch, dueled for a slim advantage on the final turn then remained a close factor in the upper stretch before weakening with a furlong to go. POINT LOOKOUT rated back off the rail, bid four wide into the final turn, lost some ground past the quarter pole and weakened in the stretch. MY CRUSADER saved ground. HOUND was kept within range of the lead while saving ground on the backstretch then faded through the final turn.
