WICKED THUNDER moved through along the inside rail to challenge in upper stretch and won going away with good energy. ARCTIC RAVEN broke sharp to contest the pace then was no match for the winner in the final furlong. BOUNCED BACK made a run into the stretch then lacked a further bid and was easily third. ROUND TRIP LONER dueled for the early lead racing two wide then weakened. BAMA BULLY raced five wide around the turn then flattened out in the drive. SLICK VIC prompted the early pace outside the top two then tired. BRAXTON COUNTY prompted the early pace four wide then tired.
