LUCKY LADY LAWYER moved up from the outside on the far turn to gain the show. CHARLI SUNSHINE failed to menace with a mild bid in the stretch. SUE'S SWEET SIOUX was away in good order and stalked the pace for six furlongs then flattened out in the drive. THE REAL FUTURE tired.
