**Footnotes**

TINDER LORD dueled from the outset, gained a short lead into the final furlong then displayed strong stamina to just last late. G MAN JOE made a four wide middle move to contention, angled inside in the drive then finished willingly to just miss. FLEET OF FRIENDS stalked the pace three wide into the stretch then slowly weakened. WEST BIRCH was well placed but failed to gain in the drive. MERCADIAN dueled inside to mid stretch then gave way. TAPE DECK failed to menace. STORDDIM was through after a half. LIGHT SEEKER looped five wide through the second turn moving to contention then flattened out. BON CIEL was through early. HIGHWAY EIGHTEEN broke down and fell inside the final furlong. There was a stewards inquiry conducted into the race before the results were declared official. TINDER LORD WAS DISQUALIFIED FROM FIRST TO UNPLACED FOR POSITIVE POST RACE TEST.
