LUSBY sprinted clear, was unchallenged setting a slow pace then drew off when called upon out of the second turn. DEBERE made a middle move outside after six furlongs and was best of the rest. LOOKN BOLDN BRASSY made a middle move to the stretch but failed to sustain that bid. ALL THAT CHATTER made a wide middle move then flattened out. ROBERTO'S GIRL raced evenly. DELLA STREET was well placed for six furlongs then faded. VIGNERON was through after a half. J. D.'S HARLEY stopped.
