MERRY BERRY showed speed from the outset and lacked the needed closing response. TARA failed to seriously menace with a mild stretch bid. ASHLEYS DUE flattened out in the drive. TIMBER LANE was shuffled back at the start. DAZZLE AND SHINE was outrun. POP TUNE showed early speed along the inside then tired.
