**Footnotes**

FIFTH DISTRICT made a middle move in the turn, angled out three wide for racing room leaving the second turn then after driving past the leader into the final furlong, lasted late. SCARLET AND GOLD was void of early speed, fanned five wide out of the second turn then was gaining outside late. GREAT INVESTMENT was void of speed to the stretch then closed a gap but too late. DISTORTED APPEAL set a strong pace into the final furlong before just hanging. NORTHERN HAMMER chased for six furlongs, bid into the stretch then weakened late. WILDLEE CERTAIN was well placed for six furlongs then gave way. CUSABO showed little. DISTINCTIVE ALIBI stopped. CURE THE FEVER stumbled badly at the break, breaking down in the left hind leg. There was a stewards inquiry conducted into the incident at the start before the result was declared official.
