**Footnotes**

STARSHIP DAYDREAM was unhurried early, split rivals while making a middle move after five furlongs then swung to the middle of the track for the drive and ran down VOLHYNIA in the final 40 yards. VOLHYNIA sprinted clear, was well rated setting a moderate pace, drew off a bit out of the second turn then resisted gamely to late before hanging while best of the rest. BLUSHING VALLEYS made a middle move to be in striking position out of the second turn but failed to sustain that rally. SHE'S ROSALIE JANE chased the winner for six furlongs then gave way. SUMMER STONE raced evenly. HEAVENS BELLE weakened gradually. STOLEN HALO was well placed to the second turn then stopped. WORLDLY PLEASURE stumbled badly at the break, unseating her rider. There was a stewards inquiry held into the incident at the start before the race was declared official.
