DOUBLE THREAT raced close up early, bid three wide after five furlongs then prevailed late after a prolonged drive. TODAY'S MAN made a three wide middle move, loomed a threat outside the winner a furlong out but hung late. GOOD GENERAL dueled from the outset then resisted well to late before also hanging. CALVELLO passed tiring rivals. REHOBOTH failed to menace. DOC'S FRIEND dueled for six furlongs then faded. BEIJING HOUSE showed little. SILVER EAGLE was unprepared at the break, lunged in the air and unseat his rider. Following a stewards inquiry SILVER EAGLE was declared a non starter.
