DEED TO THE GATE unhurried early, made a four wide middle move to contention out of the turn then outdueled MINT LANDING after a stiff drive. MINT LANDING stalked the pace early, angled out three wide to challenge from between rivals after a half then also continued gamely through a long drive before just missing. SOCO CREEK fanned four wide in upper stretch then was slowly gaining outside the top two. AMAZING BEAUTY dueled into the stretch then weakened. IMAGE OF MOTHER stopped.
