JUDGE DAISY was unhurried early, split rivals in the furlong grounds then was going well late. DANCING DILIGENCE was well placed but failed to respond in the drive. BRIDGET OF EIRE was well placed but had no rally. PLAYS POPS CHOICE passed tiring rivals. BIT OF ATTITUDE chased to mid stretch then weakened. TALKIN ROBYN raced evenly. TURN TO ROMEO also raced evenly. AMAZEL ME failed to menace. SLY MOON was no factor. WEEBITOFLUCK was through early. HELLO ALL stopped.
