BRUSCA saved ground setting the pace and shook off RISKY LOVE on the far turn, drifted out in mid stretch and was straightened then was bumped by VINES OF JUSTICE nearing the finish and narrowly prevailed. VINES OF JUSTICE made a run on the final turn then closed gamely, got in and bumped the winner late and just missed. STORMY HOUR, unhurried early, gained third with a mild bid. RISKY LOVE prompted the pace to the far turn then faded. PAR GOLFER tired. ARKAH showed little. CAMMY BE KWIK was through early then outdistanced. A stewards inquiry was conducted into the bumping incident nearing the finish.
