THE DEPUTY IS HOME was shuffled back at the start then circled rivals leaving the turn and finished second best. MR. COMMISSIONER bobbled at the start, moved closer on the turn then lacked a further response. SEA INLET chased the winner to the stretch then weakened in the drive. SEASON TICKET showed early speed and tired.
