PUMPKIN PIE chased outside or alongside a rival, came three deep into the stretch, rallied under left handed urging to collar the pacesetter in deep stretch and was in hand the final strides. NANA BEACH angled in and dueled outside a rival, kicked clear on the backstretch, opened up inside on the turn, remained clear under urging past midstretch, shortened stride in the final sixteenth and had the rider lose the whip on the wire. CASH IN HAND settled outside then chased outside a foe, came out on the turn and four wide into the stretch and just missed the place. MIRACLE MERGER bumped and in tight between horses early, chased just off the rail then inside, split horses on the turn, angled back to the rail into the stretch and lacked a rally. LADY ARAGORN broke in a bit, chased inside then just off the rail, came out into the stretch, drifted in some and was not a threat. KALOOKAN DESERT bumped at the start and again between horses when in tight early, chased a bit off the rail, angled in leaving the backstretch, dropped back on the turn and gave way. PATTY'S PULPIT had good early speed and dueled inside the runner-up but a bit off the rail, chased into and on the turn, drifted out and dropped back in the stretch and had little left for the drive.
