STAKES Bing Crosby Breeders' Cup H. Grade 1 - Thoroughbred

FOR THREE-YEAR-OLDS AND UPWARD. By subscription of \$200 each, which shall accompany the nomination, or by supplementary nomination of \$2,000 each by Sunday, July 18, \$2,000 additional to start, with \$200,000 and an additional \$50,000 from Breeders' Cup Fund for Cup nominees only. The host association's monies to be divided 60% to the winner; 20% to second; 12% to third; 6% to fourth and 2% to fifth. Breeders' Cup Fund monies also correspondingly divided, provided a Breeders' Cup nominee has finished in an awarded position. Any unearned Breeders' Cup Fund monies will revert to the Fund. Weights Monday, July 19. A trophy will be presented to the owner of the winner. Nominations closed Thursday, July 15, 2004 with 14 nominations.

Footnotes

KELA dropped back off the rail without early speed, moved up boldly four wide on the turn and into the stretch, gained the lead three deep just past the eighth pole and gamely prevailed under some urging and good handling. POHAVE four wide early, stalked three deep, took a short lead between horses nearing midstretch, could not match the winner but was clearly second best. HOMBRE RAPIDO sped to the early lead and angled in, set the pace a bit off the rail, fought back in midstretch and bested the others. REVELLO stalked inside then fell back some a half mile out, came out into the turn and three deep into the stretch and lacked the needed rally. ATTACK ALERT between horses early, stalked along the inside to the stretch and weakened. GREEN TEAM wide early, chased outside, split horses early on the turn, came three deep into the stretch and could not offer the necessary response. COURT'S IN SESSION also wide early, chased outside then between foes, split horses twice on the turn and did not rally. GLICK close up stalking the pace between horses to the stretch, weakened. DISTURBINGTHEPEACE a bit crowded at the start, settled just off the rail, came out in the stretch and failed to menace. BEAU'S TOWN had good early speed to stalk between horses, was shuffled back leaving the backstretch, dropped back and angled in on the turn and weakened.
