Footnotes

SUNSHINE HIGH stalked the pace outside then three deep, bid three wide leaving the turn, took the lead into the stretch, inched clear under urging past midstretch and held. HOUT BAY chased outside, went five wide into the turn, continued four wide leaving the turn and into the stretch and edged a rival late for second. TECHNICALITY between horses early, stalked the pace inside, continued along the rail on the turn and in the stretch and was edged for the place. A NATURAL stalked three deep then between horses on the turn, bid between foes into the stretch, continued a bit off the rail in the lane and lacked the needed late kick. WARREN'S CITY ART settled inside, went outside a rival on the turn, angled back to the inside into the stretch and improved position. WARREN'S PERFORMER chased inside, steadied sharply in tight leaving the backstretch and again early on the turn, came out into the stretch and also

improved position but was not a threat. ROYAL CHAVELA bumped between horses and squeezed at the start, chased between horses or a bit off the rail, angled in on the turn and did not rally. LOLLY GOGGIN stalked between rivals on the backstretch and turn, came out into the stretch and weakened. MISS BUSY had speed between foes then dueled outside a rival, dropped back on the turn and also weakened. LORENBRAY bobbed at the start, was sent along and lugged out some early, dueled a bit off the rail then inside, fought back on the turn, came out some into the stretch and had little left for the drive. MAMA JANKA between horses early, chased outside, went three deep on the turn and five wide into the stretch and weakened.
