SPEED ROUSER stalked a bit off the rail then inside, came out on the second turn and four wide into the stretch and rallied under urging to prove best. COMMON TRUST chased outside, bid three deep on the backstretch and second turn and between horses nearing and into the stretch, fought back in the drive, could not match the winner late but held second. T TOWN FAME a bit washy at the gate, chased between horses, came out on the second turn, was fanned five wide into the stretch and finished well. JASJONJAKE off a bit slowly, raced five wide on the first turn, chased outside, bid four wide on the second turn and three deep into the stretch, gained a short lead, could not quite match the top pair late and lost third. ACCOUNTABLE EVENT chased between horses, came three deep into the stretch and lacked the needed rally. AMERICAN PROPHECY sped to the early lead, dueled inside on the backstretch and second turn and weakened in the stretch. COACH TED off a bit slowly, saved ground off the pace, steadied in tight on the backstretch, came off the rail late and did not rally. BARGAIN BASKET stalked a bit off the rail early, bid between horses and dueled on the backstretch and second turn,

dropped back into the stretch and weakened. GNARLEY off a bit slowly, threw his head and steadied early, went four wide into the first turn, chased outside, dropped back on the second turn and also weakened. INOITWHENICIT pulled early, went between horses into the first turn, trailed off the rail and was outrun. A claim of foul by the rider of T TOWN FAME against the winner for alleged interference nearing the stretch was not allowed by the stewards, who ruled the videotape failed to substantiate the claim.
