Footnotes

AREUTRUE chased outside then three deep on the backstretch and turn, came four wide into the stretch, gained the lead outside foes in midstretch and won clear under urging. GOLD STAR settled outside a rival or between foes chasing the pace, continued alongside a rival on the turn, split horses in midstretch and gained the place. INTOTHEWILD had speed three deep then dueled outside a rival, battled between foes on the turn, took a short lead into the stretch, fought back in midstretch and held third. HALO'S LAW settled off the pace inside, came out into the stretch and just missed the show. ELUSIVE MOMENT had speed off the rail then stalked inside, continued outside a rival on the turn, came out three deep into the stretch and lacked the needed rally. GOLD STOCK saved ground chasing the pace, continued a bit off the rail on the turn and into the stretch, waited momentarily off heels in midstretch and could not offer the necessary response. COLE'S FAVORITE dueled a bit off the rail then inside, fought back into the stretch and weakened in the final furlong. LAKE MEZA settled off the rail or outside a rival, came out into the stretch and did not rally, then did not return to be unsaddled and was vanned off. STATHY stalked outside a rival and briefly between foes, bid three deep on the turn and into the stretch, was in tight between horses nearing midstretch and weakened. RUNNING BEAR settled off the pace outside or out from the rail, continued outside on the turn and four wide into the stretch and lacked a further

response.
