OBVIOUSLY (IRE) sped between horses to the early lead, angled in on the first turn, set the pace inside, inched away leaving the second turn, drew off in the stretch under a vigorous hand ride and a snug hold late. RACING APTITUDE saved ground stalking the pace, came a bit off the rail in the stretch and held second. THIRTYFIRSTSTREET pulled between horses then chased off the rail, came out three wide into the stretch, drifted inward in midstretch and outfinished a rival for third. BRUCE'S DREAM broke out and a half step slowly, pulled under a long hold to be reserved off the pace inside, inched forward leaving the second turn and into the stretch, continued inside and was outfinished for the show. KEY DECISION (ARG) stalked three deep then outside a rival, dropped back between foes in the stretch and was eased late.
