TEMPERA stalked the leaders outside, ranged up three deep on the turn, took command outside GEORGIA'S STORM in hand entering the stretch and drew well clear under a mild hand ride. RESPECTFUL bumped at the start, saved ground chasing the pace, came out in midstretch and gained the place. ROARING BLAZE broke in and was bumped then was squeezed early, settled a bit off the rail, moved up outside a rival on the turn and three deep into the stretch and held third. GEORGIA'S STORM sped to the early lead and angled in, dueled inside a rival but off the rail, inched away on the turn, resisted when initially challenged inside the winner leaving the turn but weakened in the stretch. PAST YOU stumbled and broke inward at the start, angled in and saved ground, split horses leaving the turn and again into the stretch but could not offer the needed late kick. MARTIAL'S PRINCESS had good early speed and dueled outside a rival on the backstretch and into the turn, continued just off the inside and weakened. MS LOUISETT settled off the early pace, split horses leaving the backstretch, angled in approaching the stretch and also weakened. DAYBREAK DAWN squeezed back sharply at the start, saved ground to the stretch and was outrun.
