**Footnotes**

CACTUS JANE chased inside a rival into the turn, saved ground around the turn, rallied inside the pacesetter leaving the furlong marker and was drawing away at the finish. LAKE BELIEVE chased outside a rival into and around the turn, came into the lane three wide and rallied on the outside to gain the pace in the late stages. JENNY JENNY EMILY crossed over from the outside post to take the early lead, crowded a rival on the backstretch, maintained a clear advantage in midstretch while drifting out and weakened in the final furlong. SLANE CASTLE chased on the inside around the turn, remained inside for the drive and failed to threaten for the major awards. FORTY PACES steadied inside JENNY JENNY EMILY on the backstretch, angled outside that one on the turn, came into the lane between rivals and weakened in the final furlong. BENEZIA raced between horses into the turn and lacked a rally in the stretch drive. FIL'SLASTSCORE chased three deep into the turn and was without a bid when asked at the top of the lane. WARREN'S NATALIE lacked early speed and failed to make an impact. Following a stewards' inquiry, JENNY JENNY EMILY was disqualified and placed fifth for interference on the backstretch.
