ISLAND RUN settled off the pace inside, came out on the turn and four wide into the stretch, rallied under a tap of the whip and a vigorous hand ride to gain the lead in deep stretch and proved best. MARK OF A WARRIOR had speed four wide then stalked outside, bid three deep leaving the turn, took command into the stretch, kicked clear, could not hold off the winner but saved the place. SPECTACULAR SLEW chased off the inside, angled in leaving the backstretch, awaited room along the fence into the stretch and until midstretch, went around a rival in deep stretch and got up for the show. SILVER SQUALL had good early speed and dueled inside, fought back on the turn and into the stretch, then weakened but just lost third. ALIZA'S DREAM chased outside, went three deep on the turn and four wide into the stretch and was outfinished for a minor award. MARGARITA SHOT wide early, settled off the rail, angled in for the turn, split rivals on the bend, came out into the stretch and could not summon the necessary response. LEGAL SEPARATION had good early speed and dueled between horses to the stretch, then weakened. ROCK 'N RULE had speed between horses then stalked off the rail, came out some into the stretch and also weakened. SONGFOYA chased off the rail, angled to the inside for the turn and did not rally. BRENDASGOLDENNUGET dropped back between horses, settled off the rail, was pulled up leaving the backstretch and vanned off.
