### Footnotes

TRIAL BY JURY stalked the pace outside a rival then off the rail on the second turn, bid outside the pacesetter into the stretch, took a short lead in upper stretch and held on gamely under left handed urging. STRATUS (ARG) pulled early, stalked the pace inside, awaited room leaving the second turn, came out onto NATIVE DESERT in midstretch and closed gamely three deep between foes on the wire. LUCAYAN CHIEF (IRE) took the early lead and angled in nearing the first turn, set the pace inside, fought back through a stiff drive and continued willingly to the end. SEQUOIAN three deep leaving the chute and into the first turn, chased outside a rival, came three wide into the stretch and closed gamely four wide on the line. EARL OF DANBY angled in approaching the first turn and stalked inside, came out in midstretch and lacked the needed late kick. BOURBON COUNTY angled in on the first turn and chased inside, came out on the second turn and three deep into the stretch and could not offer the necessary rally. NATIVE DESERT off a bit slowly, chased outside a rival then between horses into the stretch, was bumped between foes and steadied sharply in tight quarters in midstretch and dropped back. Following a stewards' inquiry, STRATUS was disqualified and placed seventh for interference in midstretch.
