JUDICIOUS stalked the pace inside, came out into the stretch, bid three deep in the lane, gained the advantage under urging nearing the sixteenth pole and proved best. FOR YOU MY HEART had good early speed and dueled outside a rival, put a head in front in the stretch, fought back between horses to deep stretch, could not match the winner late but held second. MICHAILASHEARTLITE chased outside then alongside a rival, came three deep into the stretch and gained the show late. TUESDAYS WITH P went up inside to duel for the lead, fought back on the turn and in the stretch and weakened late. RACHEL JONES angled in and saved ground chasing the pace, continued along the rail on the turn and into the stretch and lacked the needed rally. PEACEFUL TOWN between horses early, settled off the rail then angled in some, swung out into the stretch and again in upper stretch and could not summon the necessary response. LILY AMORE also between foes early, stalked three deep on the backstretch and turn and weakened in the stretch. BIG TSIMMIS pulled her way along to stalk the pace between horses, was in a bit tight early on the turn, dropped back between foes leaving the turn and also weakened. DEARLY CONCERNED three deep early, chased outside, went four wide into and on the turn and into the stretch and had little left for the drive.
