CANDY FACTORY angled in and saved ground chasing the pace, came out leaving the second turn and into the stretch and rallied under urging to prove best. WENDY'S ON TO ME sped to the early lead, set the pace a bit off the rail then inside, drifted out then in from the whip in the final furlong, could not hold off the winner but saved the place. BALTIC DIP (IRE) angled in and pulled her way along between horses chasing the pace, went outside a rival on the second turn and four wide into the stretch and just got the show. SUNNY DISPOSITION forced out on the first turn, stalked outside a rival, bid alongside the runner-up in the stretch and was outfinished. BEND saved ground chasing the pace, moved up inside on the second turn and into the stretch, was in tight and steadied behind the runner-up in deep stretch and was edged for the show. MADISON MEADOWS chased three deep then outside, angled in on the second turn, came out into the stretch and lacked the needed rally. ALL AGLOW chased off the rail then outside a rival, came four wide into the stretch and lacked the needed response. SMOKEGETENYOUREYES broke out a bit, settled three deep chasing the pace and did not rally. SWEET DEE'S rank and steadied early, lugged out on the first turn, angled back in and stalked inside, came out into the stretch and weakened. The stewards conducted an inquiry into the late stretch run between the runner-up and BEND but made no change when they ruled the latter had room on the rail. A claim of foul by the trainer of ALL AGLOW against the winner for alleged interference leaving the second turn was not allowed by the stewards, who ruled the videotape failed to substantiate the claim.
