**Footnotes**

STORMING BRONX sped to the early lead, drifted out and set the pace off the rail, responded when the runner-up loomed in the stretch and won clear under some urging while drifting out some late. MARKMEGOOD stalked the pace inside, inched forward to loom a threat in midstretch, could not match the winner but was clearly second best. PRINCE CARSON close up stalking the pace outside the runner-up then off the rail leaving the turn, held third. VALID STAR chased off the inside on the backstretch and turn, angled in a bit on the bend, came out in the stretch and was edged for the show. DIVORCE ATTORNEY off a bit awkwardly, settled out from the inside, angled in on the turn, came out into the stretch and improved position. A TOAST TO TANNER chased inside, split rivals on the turn, came out into the stretch then drifted in and did not rally. SANTA'S SLEIGH chased between horses then outside a rival, found the rail in the stretch and weakened. STRINGTOWN SLEW angled in and stalked the pace inside, remained on the rail and also weakened. POINT THUNDER chased outside then three deep on the turn and into the stretch and failed to menace.
