MALIBU PIER pulled three deep then outside a rival, angled in on the first turn and set a pressured pace inside, drifted out some in upper stretch, fought back off the rail, inched away under urging in deep stretch and held gamely. HEMERA angled in and settled off the pace inside, came out leaving the second turn and three deep into the stretch and finished well. HARD WAY TEN pulled inside then came out a bit in the run to the first turn, steadied when forced out leaving that turn, went three deep on the backstretch and between horses on the second turn, bid three wide in the stretch, was bumped and forced out just past the eighth pole and continued willingly. HOLY FLAPPER angled in and stalked inside, bid along the rail in the stretch and was outfinished. SANDY CHEEKS angled in and chased outside a rival then three deep leaving the backstretch and on the second turn, came five wide into the stretch, steadied off heels in midstretch and could not quite summon the necessary late kick. LAVA GIRL chased outside a rival then between horses on the backstretch, continued inside on the second turn and lacked the needed rally. NINTH INFANTRY pulled between horse then dueled inside, came out and bid again alongside the winner on the backstretch and second turn, was floated out a bit in upper stretch, came in then shifted out to bump HARD WAY TEN in midstretch and weakened late. MISINJENNUOUS angled in and saved ground chasing the pace, came out on the second turn and into the stretch and could not offer the necessary response. PULPIT MAGIC pulled early, chased outside a rival, went three deep on the backstretch, bid three wide on the second turn, came four wide into the stretch and weakened. The stewards conducted an inquiry into the bumping in midstretch but made no change when they ruled NINTH INFANTRY was responsible for the trouble.
