Footnotes

SUBPOENA THE DRESS stalked outside then four wide a half mile out, angled in off the rail on the turn, came three deep into the stretch, gained the lead outside a rival in midstretch, inched away under left handed urging and held. AKEELA saved ground off the pace, moved up inside leaving the turn, came out in midstretch and finished well. INDIARA dropped back outside then off the rail, angled in leaving the turn, also came out in midstretch and put in a late bid outside. LIT DE BET had good early speed and dueled outside a rival, fought back inside the winner in midstretch, weakened some in deep stretch and was edged for a minor award late. CATO MAJOR saved ground chasing the pace, came out leaving the turn and into the stretch and lacked the needed rally. JUDGE JOAN broke out and bumped a rival, went up inside to duel for the lead, fought back into the stretch but weakened in the final furlong. MISS PEANUT steadied when squeezed at the start, pulled her way up between horses to stalk the pace, was shuffled back a bit leaving the backstretch, continued outside a rival on the turn and off the rail into the stretch and could not offer the necessary response. SING SING CINDRELA bobbled at the start, stalked between horses then outside, was three deep on the turn and into the stretch and weakened. FAIR KISSES dropped back outside then settled off the rail, drifted four wide into the stretch and had little left for the drive.
