KATIE'S TEN chased off the rail, came three deep into the stretch, rallied under some left handed urging to gain the lead in deep stretch and proved best. WADE COUNTY dueled three deep then outside a rival into the turn, inched away on the bend, held on well to deep stretch but could not contain the winner. ROSES FOR JONI sent inside to duel for the lead, stalked on the turn, came a bit off the rail in the stretch and held third. WRINKLE ROOM allowed to settle off the rail, came three deep into the stretch and lacked the needed rally. MS PIANIST saved ground chasing the pace, steadied sharply off heels into the turn, steadied again in tight leaving the turn and could not offer the necessary response. PURPLE THUNDER dueled between horses, dropped back into the turn, continued between foes on the bend and weakened. FIRE WISE stalked outside a rival, came three deep into the stretch and also weakened. MY MAGNOLIA unhurried off the rail on the backstretch, angled in some on the turn and failed to menace.
