**Footnotes**

EVENING TWILIGHT duelled outside a rival then between horses on the turn and into the stretch, regained the advantage past the eighth pole under left

handed urging and gamely prevailed. WARREN'S LADY angled in and stalked off the rail, bid three deep on the turn, put a head in front in midstretch and continued willingly between foes late. JADE'S SONG stalked between horses then outside a rival on the turn, came out into the stretch and finished well three deep on the line. JUNES BLUE MOON chased a bit off the rail then inside, was shuffled back some leaving the backstretch, came out on the turn and three deep into the stretch and had a mild bid. MISS MYSTIC was sent along inside to duel for the lead, fought back on the turn and into the stretch and weakened in the final furlong. BENEZIA broke in the air and slowly, settled off the rail, angled in entering the stretch, split horses in midstretch and lacked the needed rally. BARBARY COAST GIRL angled in and stalked inside to the stretch and weakened. PRIDE HUNTER broke slowly, settled a bit off the rail, came out in upper stretch, was crowded off heels past the eighth pole and was not a threat. GOLDEN TRANQUILITY stalked between horses then a bit off the rail on the turn, angled in leaving the bend and weakened. LADY DERBY chased a bit off the rail then outside a rival into the stretch and did not rally. AURELIA D settled off the rail then three deep, continued outside a rival leaving the backstretch, came out on the turn and four wide into the stretch and failed to menace. HEY LOOK ME OVER stalked outside then four wide on the backstretch, continued outside on the turn and three deep into the stretch and weakened.
