Footnotes

ENRICHED pulled early, stalked off the rail, bid alongside the pacesetter on the second turn, gained the lead into the stretch, kicked clear under urging inside in the drive and held gamely. QUARTER MOON chased off the rail, came out on the second turn and four wide into the stretch and closed willingly. FIRE BREAK pulled early, angled in and settled inside, came out leaving the second turn, swung four wide into the stretch and rallied between rivals in the drive to edge a foe for third. BLAZING SPIRIT a half step slow to begin, settled outside a rival, came out leaving the second turn and five wide into the stretch, split horses in the drive and was edged for the show. ACCLAMATION pulled inside chasing the pace, came out for room into the stretch and could not summon the needed late response inside. CONCERTO'S THUNDER four wide early, stalked outside a rival then three deep leaving the second turn and into the stretch, was between horses in midstretch and lacked the necessary rally. PALLADIAN GENERAL saved ground off the pace, came out some in the stretch and was not a threat. NITRO ACTIVE pulled between horses then chased off the rail, went between rivals again on the second turn, steadied and was forced out some into the stretch, continued between foes in the drive and did not rally. SOGNATORE (FR) took the early lead and angled in, set the pace inside, dueled along the rail leaving the second turn, dropped back into the stretch and had little left in the drive. A claim of foul by the rider of NITRO ACTIVE against ACCLAMATION for alleged interference into the stretch was not allowed by the stewards, who ruled the incident minor and that it did not alter the original order of finish.
