Footnotes

SHORE DO pulled between horses and steadied off the rail on the first turn, stalked a bit off the fence then inside, came out into the stretch and again in upper stretch, bid four wide then between foes past midstretch, gained the lead in late stretch and gamely prevailed under urging. NUTZAPPER pulled his way along off the rail then chased outside a rival, went four wide on the second turn and into the stretch, steadied behind the winner in upper stretch, bid five wide in deep stretch and went willingly to the wire. WINNING YIELD stalked the pace inside, came out into the stretch and in upper stretch, bid between foes past midstretch and also continued gamely to the wire. CRIMSON STAR had speed between horses then dueled inside, fought back in the stretch and was outfinished late. SPORTSBOOKJUNKEE pulled his way along three deep then dueled outside a rival, also fought back between horses in the stretch and weakened a bit late. DIXIE MON four wide on the first turn, chased outside, went three deep on the second turn and into the stretch and had a mild bid. RHETORICALLY angled in and saved ground off the pace, moved up inside into the stretch and could not summon the necessary late kick. TOP GONE three deep on the first turn, stalked off the rail, came out some in the stretch and did not rally. BIG MAHOGANY settled outside a rival, came three deep into the stretch and lacked the needed late kick. RAVIN D'OR pulled between foes early then stalked outside a rival, dropped back on the second turn and weakened. A claim of foul by the rider of NUTZAPPER against the winner for alleged interference in upper stretch was not allowed by the stewards, who ruled the latter did not come out sufficiently to warrant a disqualification.
