Footnotes

JOYFUL MEETING stalked off the rail on the backstretch and turn, took the lead alongside the pacesetter into the stretch and drew off under a strong hand ride until the late stages. SHELLYS TERMS quickly sprinted clear, set the pace off the rail, was no match for the winner but held second. DOTTED SWISS between horses early, angled in and chased inside, remained along the rail in the stretch and bested the rest. CALIFORNIA CASUAL unhurried outside on the backstretch, continued off the rail on the turn and a bit wide into the stretch and did not rally. CHILL PHILL stalked the pace outside on the backstretch and three deep on the turn, continued outside a rival into the stretch and weakened. NADIRA chased inside then a bit off the rail on the turn and lacked a response in the stretch. SORRYTOTELLYOU unhurried well off the rail on the backstretch, continued off the inside on the turn and wide into the stretch and was outrun.
