Footnotes

CHIEF TEDDYBEAR five wide early, angled in and chased outside a rival, came out leaving the turn and four wide into the stretch, rallied to the front past midstretch and won clear under steady handling. CAYAMBE had good early speed and dueled inside, inched clear in the stretch, could not hold off the winner and just saved the place. FANDABIDOO chased inside, came out under right handed pressure into a rival's path past the eighth pole and just missed second. ASTERI settled off the rail then inside, came out leaving the turn and three deep into the stretch, steadied in tight between horses in midstretch and could not recover. COLONEL CHICK chased between horses then outside or off the rail, came four wide into the stretch and did not rally. CRY ME NO RIVER dueled outside the runner-up to the stretch and weakened. ORLANDEL four wide between horses early, chased outside a rival then off the rail, steadied at the fallen runner in midstretch and weakened. SUNSHINE RIDGE chased outside a rival, was between horses in the stretch, clipped heels and fell past the eighth pole. Following a stewards' inquiry, FANDABIDOO was disqualified and placed last for interference midstretch. A claim of foul by the rider of ASTERI against the winner for alleged interference in midstretch was not allowed by the stewards, who ruled the latter was not the cause of the trouble to the former.
