APPEALING RESUME stalked outside a rival then three deep on the turn and into the stretch, rallied under urging to gain the lead in deep stretch and held gamely. TRUE EXPECTATIONS a bit slow to begin, angled in and settled inside, waited off heels behind the eased up horse on the turn then came out leaving the bend, went around a rival nearing midstretch and finished well inside. PRINCESS SUANCES stalked outside foes then bid alongside the leader into the turn, took a short lead leaving the bend, kicked clear in the stretch and held on well to deep stretch but was caught late. ROMAN CHARITY chased inside then a bit off the rail, went between foes into and on the turn, came out in upper stretch and finished with interest. KALK BAY chased between horses then a bit off the rail on the turn and into the stretch and lacked the needed late kick. J AND S EXPRESS angled in and settled outside a rival then between foes leaving the backstretch, came out on the turn and five wide into the stretch and lacked the necessary rally. ENTABENI chased outside then three deep on the backstretch and turn, came four wide into the stretch and lacked a further response. KISS MY SWISS stalked inside, waited in a bit tight off heels behind the eased up horses on the turn, went around that one then angled in again and weakened. WINTER BLOSSOM sped to the early lead, angled in and set the pace a bit off the rail, dueled inside on the turn, weakened in the stretch, was being prepared to be vanned off after returning to be unsaddled

when she got loose and ran into the barn area. WARREN'S LEADGIRL had good early speed and stalked inside, dropped back on the turn while being pulled up, was eased in the stretch, crossed the finish, was unsaddled at the end of the stretch and vanned off.
