FETE chased outside on the backstretch and turn, came five wide into the stretch to gain the lead and gamely prevailed under some urging and steady handling. PADDY MURPHY set or forced the pace four wide, regained the lead three deep leaving the turn, fought back off the rail in the stretch and held second. SENSATIONAL SCORE unhurried off the rail on the backstretch and turn, came four wide into the stretch, rallied between foes then split rivals at the wire for the show. NERINX chased inside, split horses into the stretch, bid along the rail in the drive and was edged late for third. COURT'S IN SESSION chased between foes then a bit off the rail, came out leaving the turn and four wide into the stretch and was outfinished. ONE ON THE HOUSE chased

outside, went three deep on the turn and five wide into the stretch and lacked the needed rally. YES HE'S A PISTOL allowed to settle outside, went three deep into and on the turn and also came five wide into the stretch but could not summon the necessary late kick. TRULY A JUDGE in a bit tight early, settled between horses then a bit off the rail and did not rally. CHIPS ARE DOWN prompted the pace three deep between foes, dropped back leaving the turn and weakened. DR. EINSTEIN went up inside to duel for the lead, also fell back leaving the turn and weakened. BROOKER had good early speed and dueled between horses, fought back a bit off the rail leaving the turn and had little left for the stretch.
