LYNCOLA (CHI) three deep into the first turn, chased outside a rival, moved up outside on the second turn and five wide into the stretch, rallied under urging to the lead in deep stretch and proved best. ICE-GIRL (ARG) sped to the early lead and angled in, set the pace inside, kicked clear on the second turn but could not hold off the winner. CLICKETY CAT angled in and saved ground off the pace, moved up inside leaving the backstretch and on the second turn, came out into the stretch, was between horses in midstretch and held third. LIFE'S PLEASURES unhurried and angled in early, advanced inside on the second turn and into the stretch to loom a threat and was edged for the show. DESERT VIEW (GB) chased off the rail then outside a rival, continued three deep on the second turn and four wide into the stretch and weakened. SHY RUTILANTE (ARG) three deep into the first turn, chased outside a rival, came out into the stretch and also weakened. TERESA ANN prompted the pace outside the runner-up on the first turn, stalked off the rail on the backstretch and outside a rival leaving the second turn and had little left for the stretch. EXPRESSWAY close up stalking the early pace inside then a bit off the rail, had the top pair kick away on the backstretch, dropped back on the second turn and gave way.
