MORGANOUSKA sped to the early lead, set all the pace along the inside, opened up on the backstretch and drew off in the stretch under a steady hand ride and a couple late taps of the whip. MY LAST TYCOON chased inside, came out leaving the second turn and in the stretch and held second. CASA O wide early, angled in outside a rival, came out four wide leaving the second turn and into the stretch, drifted in some and bested the rest. LEYVA MAN fractious in the gate, chased off the rail or between horses, split rivals into the second turn, came three deep into the stretch and did not rally. LEWDAGW N PARADISE pulled early, lugged out and steadied on the first turn, saved ground off the pace, continued inside in the stretch and was not a threat. SWONGS broke slowly, chased between foes then off the rail, angled in on the second turn, came out in the stretch and weakened. PARTY AT MY PLACE chased three deep then outside a rival, continued outside on the second turn and three deep into the stretch and had little left for the drive. BROTHER REID broke slowly, stalked three deep then outside a rival, dropped back off the rail on the second turn, gave way and was not persevered with in the stretch. SKATTLE

SEATTLE washy at the gate then fractious in the gate, bobbed at the start, had speed between horses then stalked off the rail, dropped back fast leaving the backstretch, gave way readily and also was not persevered with in the drive.
