CAN CAN GIRL forced the pace three deep then stalked off the rail, came out into the stretch and rallied under urging to be along in time. DIXIE HAWKS dueled between horses then outside a rival then stalked a bit off the fence leaving the backstretch and on the turn and came back between foes late. PISTOIA sped to the early lead, dueled inside foes then inched away a half mile out, set the pace off the rail, remained clear past midstretch and weakened late but held third. ASKQUESTIONS LATER chased inside, came out a bit into the stretch and lacked the needed rally. GAMBLERS RULE unhurried off the rail then angled in on the backstretch, swung three deep into the stretch and improved position. WARREN'S DELIGHT chased between horses then outside a rival leaving the turn, split foes into the stretch, drifted inward in midstretch and did not rally. MA BARKER stalked a bit off the rail then inside on the turn, remained along the fence in the stretch and weakened. RIO'SFAVORITEONE hesitated to be off slowly, angled in and saved ground to the stretch, came out and failed to menace. O FIREFLY settled inside, came out into the stretch, was a bit crowded in midstretch and was not a factor. LADY KENZIE chased

outside then three deep, came a bit wide into the stretch, drifted in and weakened.
