Footnotes

KETTLE CORN settled outside a rival, moved up three deep on the second turn then four wide nearing the stretch, was fanned five wide into the drive, gained the lead, inched away and came inward in midstretch, drifted in some in the final furlong but won clear under left handed urging. JAIRZIHNO (GB) stumbled at the start, settled inside, came out leaving the second turn and three deep into the stretch, angled out in the drive and picked up the place late. OILISBLACKGOLD stalked outside a rival then three deep, bid three wide leaving the second turn, drifted out into the stretch, steadied briefly behind the winner in midstretch and just held third. JAVA MAN angled in and stalked a bit off the rail then inside, cut the corner into the stretch, bid inside and was edged for the show. QUINTONS DESTINY angled in and chased outside a rival, came out on the second turn and four wide into the stretch and put in a late bid at a minor award. BAY RUSH saved ground chasing the pace, came out a bit in the stretch and also was outfitted for a minor share. MINDBLOWER pulled his way along a bit off the rail, came out on the second turn and four wide into the stretch and lacked the necessary response. SENATOR BOB pulled his way up inside to prompt the pace, stalked a bit off the rail on the backstretch, re-bid outside a foe then between horses on the second turn, drifted out on a slim advantage into the stretch and weakened. BOOTED steadied when squeezed at the start, pulled between horses early then went up three deep on the backstretch and into the second turn and did not rally. CALIFORNIA SOLDIER came in at the start, had speed outside a rival then inched away and

angled in on the backstretch, dueled inside on the second turn, came out a bit into the stretch and weakened.
