BLUE IMP pulled her way along inside early, waited a bit then moved up leaving the turn, got through inside then came out in upper stretch, split rivals with a bid, gained the lead and proved best while drifting out a bit under urging. PONCHE DE LEONA chased inside, came out three deep into the stretch, hit the front four wide in midstretch and continued willingly but could not quite match the winner. VEE VOOM (NZ) wide in the chute, angled in outside a rival, came out into the stretch and finished with interest for third. DARLIN COREY unhurried and angled in early, settled just off the inside on the backstretch, went four wide on the second turn and five wide into the stretch and improved position. LUCKY SPIRIT chased between foes then inside, came out into the stretch,

bid between foes in midstretch but weakened in the final furlong. SKY REALITY angled in and chased outside a rival, went three deep on the second turn and four wide into the stretch and could not offer the necessary rally. CAN'T BE DENIED pulled her way to a clear lead and angled in, opened a lengthy advantage on the backstretch along the inside, continued inside in the stretch and weakened in the final furlong. BELLA NUNZI was in a good position chasing outside a rival, went three deep on the second turn and into the stretch and also weakened. SANDY SNEAKERS chased outside a rival, dropped back on the second turn and had little left for the stretch.
