PLACID LAKE chased between foes then three deep on the turn, came four wide into the stretch, gained the lead in upper stretch and proved best under urging. SPORTIE'S SQUEEZE between horses early, chased a bit off the rail then inside, bid along the fence in the stretch and bested the others. PHOEBE'S SONG chased off the rail then inside on the turn, came out into the stretch, steadied off heels in upper stretch but finished with interest. JUSTICE IS BRIEF stalked the pace outside then alongside a rival on the turn, came three deep into the stretch and lacked the needed rally. HUNSLEY BUNSLEY had speed off the rail then dueled outside a rival, drifted out on the lead into the stretch and weakened. STEELIN' stalked early then bid inside and dueled for the lead to the stretch and also weakened. LIGHT AMOUR saved ground stalking the pace, came out into the stretch and lacked the needed response. VICTORY'S LADY angled in early and saved ground to no avail. OURFAVORITEONE broke slowly, saved ground off the pace, came out into the stretch and was not a threat. GOLDEN VENTURE chased between horses, came three deep into the stretch and weakened. INCREDIBLE settled outside chasing the pace, went four wide on the turn and into the stretch and lacked a further response. ISABELLA MONIQUE unhurried off the inside early, angled

in some for the turn, came out into the stretch and failed to menace.
