### Footnotes

DEVINE WIND pulled his way to the front three deep early, angled in on the first turn, set the pace inside, came out under left handed urging twice in the final furlong but held on gamely. D'WILDCAT pulled between horses early, stalked outside a rival then a bit off the rail, ranged up behind the leader in the stretch, steadied twice off that rival's heels in the final furlong and could not get by. KACHAMANDI (CHI) stalked inside then a bit off the rail, continued between horses leaving the second turn and into the stretch, came out in midstretch and went willingly to the wire. ZANAPOUR (FR) off a bit slowly, settled inside, waited briefly before getting through inside in midstretch and was outfinished. STORMY JACK angled in and saved ground stalking the pace, came a bit off the rail in midstretch and lacked the needed response. HOOK CALL (BRZ) chase outside a rival or a bit off the inside, went three deep leaving the second turn and into the stretch and did not rally. Following a stewards' inquiry, DEVINE WIND was disqualified and placed second for interference in the stretch.
