Footnotes

HEAVENLY APPEAL dueled for the lead three deep, shook clear entering the stretch and maintained a safe advantage. ELLA POOH stalked the pace three deep, launched her bid entering the stretch, kept on well but was unable to reach the winner. CART'S CRUSIN broke slowly, advanced along the inside, checked from tight quarters near the five-sixteenths marker, split horses and came again and was making up ground. IMAGINARY FRIEND was forwardly placed along the inside, but weakened entering the stretch and faded. DYNA NEKIA was unhurried into stride, came four wide to make a steady advance but failed to seriously threaten. LAVA FIRE chased the dueling leaders four wide to the stretch and gave way. PLAY TO WIN raced wide throughout and passed only the tiring ones. MONEY MAID was unhurried into stride, made a belated gain between horses but was never a factor. DEVIL'S BARGAIN showed little. NIGHT MOVES DIVA dueled for the lead along the inside to the stretch and stopped. WYNN D'NIRO was through early.
