CRIMINAL OFFENSE sprinted clear, set the pace inside, drew off on the turn and held sway late. STEVE'S KITTEN closest to the pace off the inside, dropped back a bit on the turn then was coming again late. LOUIE MONDELLO forwardly placed from the start, raced three wide on the turn and finished willingly. GUYS REWARD outrun early, angled out four wide with three furlongs to go, came wider for the drive and closed well. SUNDAY BREW within striking distance, saved ground leaving the turn and lodged a mild bid. VAN GOAL forwardly placed, raced three wide into the turn and tired. CATONTHEGO four wide on the turn, was no threat. DYNAMITE D could not menace. PAINTED KITTEN was outrun. ENON flipped prior to being loaded into the gate, swerved in at the start, was outrun and was outdistanced.
