Footnotes

COUNSELLED gained the lead inside early, controlled modest fractions, was clear into the upper stretch, drifted out badly in the final sixteenth and held sway under urging. STORMY ATLANTIS, never far back, made a solid run four wide into the lane, lugged in at the three-sixteenths pole behind the winner, continued three or four wide the remainder and wasn't good enough. WAVE LAND GROOVY, within striking distance and three or four wide, couldn't muster the needed late response. SCOTT'S TIME, outrun for six furlongs came out eight or nine wide for the drive and managed a slight gain, UNREACHABLE STAR, reserved early and angled inside, continued two or three wide into the lane and managed a minor gain. FAITH'S MAGIC, well placed four or five wide to the stretch, flattened out in the drive. BALLACOLLA failed to menace. INDEPENDENT BANKER chased the winner four wide to the far turn and weakened gradually. A FOUL CLAIM LODGED BY THE RIDER OF STORY ATLANTIS AGAINST THE WINNER FOR ALLEGED INTFERENCE IN THE STRETCH WAS DISALLOWED.
