QUICK PRAISE close up inside, raced off the rail on the second turn, angled out for the drive and finished willingly to be up in the final stride. FLEUR DE LILLY closest to the pace outside the leader, challenged on the second turn, drew clear in midstretch but missed. MISSED THE POINT within striking distance along the inside, lodged a mild late bid. QUEEN'S AWARD within reach three wide, lacked a late bid. MAID OF HEAVEN forwardly placed three wide, moved in a path on the second turn and tired in the drive. KITTEN'S DANCER set the pace along the inside, held on well to the stretch and tired late. FIREHOUSE RED three wide early, was no threat. HEMERA was outrun. CREDIT CRUNCH had speed for a half.
