Footnotes

BLACKPOOL edged in to track the pace four wide, moved to the fore a quarter-mile out, quickly drew clear and widened when ridden out. DANCINGFORTHGREEN, never far back and between horses four or five wide, loomed prominently for the last eighth but couldn't menace as second best. KENNY'S LAD gained the lead two wide, held a slight edge until the final quarter and weakened. DRAWN ducked out at the start jolting FAITH IN ACTION, tracked the pace three or four wide to the stretch and tired. K D MAC, unhurried early, raced six wide on the far turn while advancing and failed to sustain the move. FAITH IN ACTION, jolted at the start by DRAWN, improved position but couldn't threaten. BALLACOLLA raced in contention between foes to the final quarter and flattened out. DENOCANDU raced forwardly near the inside to the head of the stretch and faltered. MY FRIEND TUFF was sluggish early and never a factor. FOUL TROUBLE, up close between foes, weakened nearing the stretch. FOUR YOUR MARQ, off the inside, was done after a half.
