Footnotes

DESTREHAN was allowed to settle, responded when roused with three furlongs to run, moved up circling five wide, drifted in a step while being asked to switch leads near the furlong marker, was straightened away, reeled in ROCKY'S WRITTEN and edged clear. ROCKY'S WRITTEN set the pressured pace along the inside, opened clear on the turn, fought on determinedly but was outfinished. DA DON stalked the pace three wide, offered a mild bid entering the stretch, was put in tight and steadied near the furlong marker when the winner came in, recovered quickly but went evenly thereafter. KING KID broke a step slow, was unhurried into stride, angled out leaving the turn but lacked a response when called upon. FORECLOSED prompted the pace two wide, was unable to match strides with the winner before going a half, faltered further between rivals on the turn and dropped out. JUDICIAL POWER settled saving ground, went wrong leaving the turn, dropped far back, was pulled up near the wire and was vanned off. The jockey of DA DON lodged an objection against DESTREHAN for alleged interference near the furlong marker, but following the Stewards review there was no change to the order of finish.
