**Footnotes**

SCOTLAND PLACE, in hand early and positioned near the inside, eased out four wide leaving the backstretch to advance, took over in the upper stretch and drew off under hand urging. CAITLINS DANCER gained a slim lead near the inside early, dueled with MS. RUBIROSOSA, held on well to the lane and couldn't match strides with the winner in the drive. MS. RUBIROSOSA went up to contest the pace outside of CAITLINS DANCER, battled forwardly to the stretch and weakened. PAR GOLFER, four or five wide and in contention for six furlongs, flattened out when the test came. BLUSHING RAINBOW, reserved early and three wide, never rallied when asked. TRIFECTA WAGERING ON THIS RACE WAS CANCELED.
